



## **The Center for American Liberty Sues Kaiser Foundation Hospitals, for Medical Negligence, After Surgically and Chemically Transitioning Chloe Cole.**

San Francisco - The [Dhillon Law Group](#) and [LiMandri & Jonna LLP](#), in conjunction with the [Center for American Liberty](#), filed a medical negligence [lawsuit](#) against the Permanente Medical Group, Kaiser Foundation Health Plan & Kaiser Foundation Hospitals who performed, supervised, and/or advised transgender hormone therapy and surgical intervention for Chloe Cole when she was a minor between 13-16 years old.

For more than 90 days, defendants ignored the [Notice of Intent to Sue](#) sent to them on November 9, 2022, leaving Ms. Cole no choice but to seek justice from a court of law.

"After we launched my lawsuit last year, there has been an explosion of both detransitioners and their lawsuits all over the country. Unfortunately, I am no longer alone in my pain and suffering," said **Chloe Cole**. "I am going forward in taking legal action because every second that goes by, more blood is spilled by the same individuals and medical centers that destroyed my body and childhood."

Center for American Liberty CEO and attorney [Harmeet K. Dhillon](#) (@pnjaban) commented: "Chloe's family sought medical treatment for her at Kaiser. Her physicians and other medical professionals violated the first norm of the profession, the Hippocratic Oath, when, instead of caring for her and providing medically competent diagnoses and treatment, they permanently disfigured her for profit. What happened to Chloe at Kaiser should never happen to any child in America, and the Center for American Liberty is committed to protecting children like Chloe."

[Charles LiMandri](#), partner, LiMandri & Jonna LLP commented: "Chloe Cole was the child-victim of three types of ideological and profit driven medical abuse: (1) fraudulent and coercive transgender indoctrination; (2) off-label use of dangerous puberty blockers and cross-sex hormones; and (3) irreversible surgical mutilation--all resulting in excruciating pain and suffering, permanent disfigurement, loss of enjoyment of life, and extreme emotional distress. We are proud to represent this courageous young woman who is trying to help other young people from also being victimized in this horrible manner."

**Background:** Chloe Cole is a biological female who suffered from gender dysphoria. When Chloe was a child, between 13-16 years-old, doctors coerced her—by concealing less invasive treatments and by lying to her about her condition—into undergoing harmful and irreversible transgender treatment, specifically, puberty blockers, off-label cross-sex hormone treatment, and a double mastectomy.

Defendants falsely represented to Chloe that her gender dysphoria would never resolve itself absent a full medical and social gender transition. Defendants also gave Chloe's parents an ultimatum: "would you rather have a dead daughter or a live son?"

Chloe's lawsuit seeks both general and special damages for the bodily mutilation, mental anguish, and pain and suffering at the hands of Kaiser Foundation Hospitals and several of its physicians individually.
