COUNT 1: Complainant, being duly sworn, states that on or about September 26, 2022, at the YMCA located at 336 S. Progress Drive, City of Xenia, Greene County, Ohio, DARREN C. GLINES did expose his private parts, recklessly and under circumstance in which his conduct was likely to be viewed by and affront others who were in his physical proximity and who were not members of his household, in violation of Ohio R.C. 2907.09(A)(1), PUBLIC INDECENCY, a misdemeanor of the fourth degree.

COUNT 2: Complainant, being duly sworn, states that on or about November 7, 2022, at the YMCA located at 336 S. Progress Drive, City of Xenia, Greene County, Ohio, DARREN C. GLINES did expose his private parts, recklessly and under circumstance in which his conduct was likely to be viewed by and affront others who were in his physical proximity and who were not members of his household, in violation of Ohio R.C. 2907.09(A)(1), PUBLIC INDECENCY, a misdemeanor of the fourth degree.

COUNT 3: Complainant, being duly sworn, states that between the dates of November 30, 2021, and November 30, 2022, at the YMCA located at 336 S. Progress Drive, City of Xenia, Greene County, Ohio, DARREN C. GLINES did expose his private parts, recklessly and under circumstance in which his conduct was likely to be viewed by and affront others who were in his physical proximity and who were not members of his household, in violation of Ohio R.C. 2907.09(A)(1), PUBLIC INDECENCY, a misdemeanor of the fourth degree.

TO WIT: Xenia Police received several reports of a naked male in the females' locker room of the YMCA located at 336 S. Progress Drive, City of Xenia. Count 1 pertains to a specific complaint wherein the person reported seeing a naked male in the females' locker room on September 26, 2022. Count 2 pertains to a specific complaint wherein a second person reported seeing a naked male in the females' locker room on November 7, 2022. Count 3 pertains to a specific complaint wherein a third person reported seeing a naked male in the females' locker room and approximated this encounter as having occurred within the last year (i.e., November 2012 through November 2022). On Count 3, it was reported that at least three (3) female juveniles were present when the naked male was in their vicinity. The Defendant

was identified by the reporting persons and the Xenia Police were able to verify the identification via their investigation.
