Sam,

I'm sorry we were not able to connect today via phone. I was hoping to talk about a few logistics. We are excited for the two sessions scheduled for April 5th. I wanted to discuss some slight changes. We scheduled an 8:15 -9:15 session for elementary faculty and a 10:00-11:00 session for administration. After some internal discussion I would like to ask if we can adjust to the following.

- Maintain the 8:15 -9:15 session for elementary faculty
- Change the originally planned 10:00-11:00 session for administration to a 9:45 start time for secondary faculty (9:45-10:45).

If the adjustment above works for you, we would simply have the relative administrators attend/view with their respective faculty groups. I am also thinking it might be valuable to have 2-3 administrators/faculty in the Google Meet with you for a Q&A at the end of each presentation, while all others will view via live stream. That would likely be me and/or the superintendent and 1-2 others. We can discuss this in more detail during our call next week if you are in agreement that this makes sense.


