16	"(1) The term 'promotes or compels a divisive

1	"(D) An individual should be discriminated
2	against or receive adverse treatment solely or
3	partly because of his or her race.
4	"(E) Members of one race cannot and
5	should not attempt to treat others without re-
6	spect to race.
7	"(F) An individual's moral character is
8	necessarily determined by his or her race.
9	"(G) An individual, by virtue of his or her
10	race, bears responsibility for actions committed
11	in the past by other members of the same race.
12	"(H) Any individual should feel discomfort,
13	guilt, anguish, or any other form of psycho-
14	logical distress on account of his or her race.
15	"(I) Meritocracy or traits such as a hard
16	work ethic are racist, or were created by a par-
17	ticular race to oppress another race.
18	"(2) The term 'race scapegoating' means as-
19	signing fault, blame, or bias to a race, or to mem-
20	bers of a race because of their race.
21	"(3) The term 'race stereotyping' means ascrib-
22	ing character traits, values, moral and ethical codes,
23	privileges, status, or beliefs to a race, or to an indi-
24	vidual because of the individual's race.".
