Weekly Report: MDM Narratives

Executive Summary

- 1. Two high risk potential MDM narratives:
 - a. Oregon's 2022 midterm elections were fraudulent. (Continuing narrative)
 - b. Mail-in ballots are used to commit voter and election fraud in Oregon. (Continuing narrative)
- 1. An Oregon-specific Telegram channel that has previously been a top vector for MDM narratives on Telegram propagated a smaller share of MDM narratives on Telegram over the past two reporting periods.
- 2. Users online claimed that Oregon Ballot Measure 114 passed due to voter and election fraud in the 2022 midterm elections.

National Trends & Developments

- 1. Users online discussed supposed voter and election fraud that occurred during the 2022 midterms:
 - a. Users online discussed Arizona gubernatorial candidate Kari Lake's ongoing election fraud claims and lawsuit.
 - b. Users online discussed potential voter and election fraud in the 2022 Georgia Senate runoff election.
- 2. Users online discussed the "Twitter files" recently posted on Twitter by journalists. This discourse could lead to increased anti-government and anti-Big Tech sentiment and therefore increased dissemination of related MDM narratives.
 - a. Users claimed that the "Twitter files" exposed how the DNC, FBI, and Big Tech (e.g., Twitter, Facebook, and Google) interfered in the 2020 election by suppressing the Hunter Biden laptop story.
 - b. Users also claimed that POTUS 45 would have won the 2020 election if the information was not suppressed.

This narrative could decrease Oregon voters' confidence in Oregon's electoral procedures and the outcomes of elections. 



Appendix C: Definitions

Definitions

- Misinformation false, but not created or shared with the intention of causing harm
- Disinformation deliberately created to mislead, harm, or manipulate a person, social group, organization, or country
- Malinformation based on fact, but used out of context to mislead, harm, or manipulate
- Topic the broader subject defining the information environment (ex. Midterm Elections)
- Theme subtopics or categories of discourse (ex. Mail-in ballots)
- Narrative at least more than one piece of content that shares a similar rhetorical objective (ex. County clerks are using mail-in ballots to steal elections)
- Voter Fraud unlawful voting by individuals (ex. voting more than once)
- Election Fraud unlawful actions that undermine election integrity (ex. tampering with official election materials)
