I first want to thank each of you for such a warm welcome on Monday, I am really excited to be working with each of you this year. I am reaching out seeking guidance about how we as EC can proceed in formally escalating concerns from our members related to the presence of FAIR in the exhibit hall this year.

I know many of you are already aware of the Daily mail piece containing Ilana's NCE session slides, but I wanted to share some additional social media posts (see below) related to FAIR being allowed access to the NCE. In addition to Julia Mason, there were multiple other prominent members of the anti-trans movement (some of whom are actively engaged in lawsuits against our members) allowed into the exhibit hall this year. Ive included a few below, but feel free to read more about each and the organizations they are affiliated with here https://transdatalibrary.org/people/0/:


- Jamie Reed- the 'whistleblower' who previously worked in the Wash U gender clinic who is currently under investigation for a HIPPA breach related to sharing gender clinic PHI with Jesse Singal, a prominent anti-trans reporter
- Chloe Cole and Prisha Mosley- detransitioners who have testified in support of care bans in numerous states and have both filed lawsuits against their prior care teams for malpractice
- Patrick Henry- a member of the FL board of medicine who was responsible for banning GAC in FL

In addition to the verbal harassment experienced by one of our trans-identified members at the booth on Sunday, I have been approached by multiple additional members of our section in the last few days who are either LGBT-identified themselves and/or providers of gender-affirming care regarding with significant concerns about the decision to allow FAIR into the exhibit hall and to allow Julia Mason to continue to be a member of the AAP. These members have expressed this decision has made many of them lose trust in the AAP and question the degree to which the NCE can be a safe space for them in the future (especially in FL next year). I know we escalated some of these concerns to Mark in our brief meeting on Monday and he provided us with verbal reassurance that something like this wouldn't happen again, but I think given the severity of what occurred and the degree of harm this decision caused to our members, we should request a formal response from leadership to ensure we get a clearer idea of what is being done internally to ensure our safety at future NCEs. This level of formality feels especially important given the additional information we now have from Morissa that there were no consequences for Julia Mason's posting a recording of her plenary on social media last year, both to reassure our members, and also any future presenters of LGBTQ-related NCE sessions, that the AAP is truly committed to making the NCE a safe space for us as LGBTQ individuals and GAC providers.
